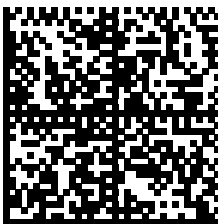

The Ombudsperson is asked to refer the Law on the Specialist Chambers to the Constitutional Court



Representatives of civil society, the academic community and human rights organizations have asked Ombudsperson Naim Qelaj to refer the Law on the Specialist Chambers and the Specialist Prosecutor's Office to the Constitutional Court.

According to the request, the Constitutional Court should examine whether the mandate of the Kosovo Specialist Chambers in The Hague has been expanded beyond the authorization provided for in Article 162 of the Constitution of Kosovo.

Article 162, paragraph 1, of the Constitution, the request states, enables the establishment of the Specialist Chambers and the Specialist Prosecutor's Office so that the Republic of Kosovo can fulfill its international obligations relating to Report No. 12462 of the Parliamentary Assembly of the Council of Europe, dated January 7, 2011, prepared by rapporteur Dick Marty.

The law, on the other hand, stipulates that the institutions were established to address proceedings concerning allegations of serious transnational and international crimes connected with the allegations in the report and investigated by the Special Investigative Task Force. According to the signatories, this shows that the Constitution did not authorize the creation of a general criminal jurisdiction without limitations.

"The Constitution enabled a specialized mechanism within Kosovo's justice system, established for a specific constitutional purpose and linked to the allegations that led to its creation," the request states.

The signatories assess that the summary of the judgment in the case against Hashim Thaçi, Kadri Veseli, Rexhep Selimi and Jakup Krasniqi has highlighted more clearly how these provisions have been interpreted and applied.

According to them, the summary extensively addresses the history, organization, leadership, and political and military structures of the Kosovo Liberation Army (KLA), public statements, appointments, intelligence services, military police, operational zones, as well as the goals of Kosovo's independence and the establishment of political and institutional control.

"The trial panel made it clear that the case did not concern the legitimacy of the KLA or its aim of an independent Kosovo. This clarification is important. Nevertheless, the breadth of the analysis raises the question of whether the connection to the specific allegations in the Report of the Parliamentary Assembly of the Council of Europe served as a genuine and effective limit on the jurisdiction, or as a basis for exercising a much broader jurisdiction over the organization and activities of the KLA during and after the war," the request states.

The request warns that if the wording "which are connected to the Report of the Parliamentary Assembly of the Council of Europe" is understood broadly enough to include every alleged crime, individual, structure, policy or development with a general historical connection to the KLA, the limitation in Article 6 could lose its legal force.
